Hospital-Based Physician Chart Instructions

This is a list of the hospitals and ambulatory surgery centers in this region that participate in the Louisiana Blue networks. Follow these steps to get the information you need:

- 1 Find the facility where you will be receiving care. They are in alphabetical order.
- 2 Next to each facility, you will see a list of the hospital-based physicians/groups who practice at that facility.
- 3 The next five columns of the table represent the specialties that are considered hospital-based and include: Anesthesiology, emergency medicine, neonatology, pathology and radiology. There will be a check mark (✓) in the appropriate specialty column for each physician or group who participates in the Louisiana Blue networks. If there is no ✓, it means that the facility does not have that hospital-based physician specialty or the facility has not reported data to Louisiana Blue (Data Not Received).
- 4 The columns in blue show whether the physician or group is:
 - ✓ Participating in Blue Cross' Preferred Care PPO network;
 - ✓ Participating in the HMO Louisiana network
 - ✓ Participating in Blue Connect network;
 - ✓ Participating in BlueHPN network
 - ✓ Participating in Community Blue network
 - ✓ Participating in Precision Blue network
 - ✓ Participating in Signature Blue network
- 5 The last column will be highlighted in red if the physician or group is:
 - ✓ Not participating in any Blue Cross network and therefore considered "out-of-network"

What you can do with this information:

If you are planning to have a medical procedure or service at a network facility that has one or more out-of-network hospital-based physician(s), you may be balanced billed for the difference between the Louisiana Blue allowable charge and the provider's billed charge. You may consider asking your doctor whether you can have your procedure at another hospital. If that is not possible, you may be "balance billed" by a out-of-network (non-contracted) provider. In that case, call the out-of-network provider's office and ask whether they will accept Louisiana Blue's allowable charge as full payment for their services.

Rights and Protections Against Surprise Medical Bills

Out-of-network providers cannot send members an unexpected bill when they cannot choose who treats them. Out-of-network providers who see members in a true health emergency cannot send them a bill for more than what their plan pays. In most cases, out-of-network providers who see members in a network hospital cannot send them a bill for more than what their plan pays without their consent.
